**Division Membership Growth Award:**

This award consists of a certificate issued by the National Commodore to be presented to the division captain of any division showing a NET gain of two (2) members during the calendar year that equals or exceeds the number of Flotillas times two (2) as shown in AUXDATA. It is not necessary for each flotilla to have a two member net gain in order for the division to receive an award.

The division captain submits an application for the NACO Membership Growth Award to the **DSO-PS**. The DSO-PS verifies the information and then sends it to the **BC-PFA** for preparation of the award.
